

The Black Lives Matter Movement

In May 2020, a white police officer named Derek Chauvin killed a black man named George Floyd in Minneapolis. George Floyd's death sparked the black lives matter social movement since it was suspected that the incident was racially motivated despite the fact that George was unarmed and not acting in any violent manner against the group of white police officers who were questioning him. As a result of this tragedy, Americans all throughout the country eventually started the social movement known as "Black lives matter." The argument of whether justice should be served was put to the test for the citizens because since Derek was a police officer, the amount of power any officer has over a citizen can prove how someone with higher power can overthrow people no matter what. I believe this was an effective use of rhetoric because the video was highly compelling to people all over the world when it appeared on social media, which helped to showcase what happened and what actions had to be done for justice to be served.

Poster signs are examples of visual rhetoric in which a person uses art to convey a message to a specific audience. During the black lives matter social movement, poster signs were used to raise awareness of the fact that racism is still prevalent and is not being dealt with responsibly in the aftermath of George Floyd's death. Protests were held outside Derek Chauvin's house in Minneapolis, with army officers guarding the perimeter. Burke's ideas of identification were also used as a rhetorical strategy in this situation. According to his theory, a speaker can create a shared sense of values, attitudes, and interests with an audience, which in this case the protesters all had the same purpose in mind: to put an end to police brutality and to fight for the justice system to treat black people fairly. Both rhetorical

choices such as social media and protesting signs combine the strength of both perspectives in order to form one strong argument because rhetorical strategies can improve communication by enhancing the power to be able to persuade others no matter what.
